Prior to the meeting, Neil Shroyer talked about the concern he has for boats leaving the country due to new NAVY administration enforcing the following:

This is the text from the Reglamento de la Ley de Navegación y Comercio Marítimo.

Artículo 477.- Para autorizar el zarpe o despacho en altura de Embarcaciones Menores de Recreo y Deportivas, la Capitanía de Puerto exigirá:

I. Constancia de no adeudo, por el uso de infraestructura o daños causados a ésta, expedido por el administrador de la marina o administrador portuario, según sea el caso;

II. Documento que acredite que la Embarcación se encuentra registrada en su país de origen;

III. Documento que acredite la capacidad técnica del patrón, y

IV. Lista de tripulantes y Pasajeros, si los hubiere.

English translation:

Law of the Navigation and Maritime Commerce Law (enforced by the Port Captains of Mexico and the Mexican NAVY)

Article 477.-Google translate says:

"Article 477.- To authorize the departure or clearance at height of Minor Recreational and Sports Boats, the Port Captaincy will require: I. Proof of nondebt, for the use of infrastructure or damage caused to it, issued by the marine administrator or port administrator, as the case may be; II. Document proving that the vessel is registered in its country of origin; III. Document certifying the technical capacity of the employer, and IV. List of crew and passengers, if any.

(Which says nothing about the operators certificate for having passed the recreational boatsmanship school unless it is covered by article III)

He suggests that any boat thinking of leaving Mexico, have some kind of Boating Certificate and showed us a booklet for obtaining the certificate from the state of California.

A discussion on the possibility of removing some book shelves and placing computer stations so that members could use them for one hour per day in the
