i. Membership – We are trying to get everyone to now register online and then put their payment in an envelope and put it in the box or pay via PayPal. We competed a one month pilot that we used to identify some challenges with the strategy we were using and have put some revisions in place to help overcome those. We did note that many of the renewing members have not been filling in the form and just putting money in an envelope with their name and putting it in the slot. It is important to note that since we need to ensure that we have an audit trail it is essential that everyone fill out the online form, even if it is to just type in your name and check the box to say that you are renewing as well as putting your name on the envelop with your money (or making your payment using PayPal) so that the Treasurer is able to connect the two with clear evidence. New signage will be put up to help ensure that everyone is clear about what needs to be done and how.

There was some concern expressed about a small group of people who will NEVER fill out an online form. However, as Steve pointed out, we can help those individuals out on a special assistance basis, but we are not going to throw out the electronic system to accommodate those few who will refuse. The benefits of the new system outweigh the potential frustrations of a few.

- j. Nominations & Elections Doug as of right now Steve Brenner will be running for commodore again. Heidi Stagg will be running for Vice Commodore. Bob Walker will be running for Rear Commodore again. Teri Hagen has agreed to continue as past commodore. Linda Keigher, Mary-Jo Hood, and Tom Murray are all running for director at large again.
